Corporate Compliance Programs

The passage of the Healthcare Insurance Portability and Accountability Act of 1996 (HIPAA) has intensified governmental efforts to reduce fraud and abuse in Medicare billing. Critical Access Hospital Designation

Provisions of the 1997 Balanced Budget Act created the designation of Critical Access Hospital (CAH) for certain facilities located in rural areas. The CAH program can result in significant reimbursement enhancements from Medicare for hospitals that qualify.
